EXPLANATIONS AND EXAMPLES

Note Well

The Belmopan Local Building Authority in an effort to recognize, harmonize and apply the confluence of Laws and Policies applicable both Nationally and to the City of Belmopan mandates as conditions precedent to the approval of a construction project:

- a. Incompletely, badly or wrongly prepared or filled in Application Documents could result in a delay of the Review process.
- b. One set of Application Documents shall be filled in for each structure on each Parcel.
- c. The statement in the second part of the statement at requirement 26 of the Form on page 4 "*I also accept full responsibility for the correctness and suitability of the information provided in the other documents submitted along with this Application Form.*" For this reason the *Professional of Record* needs to select (or if selected by the Project Owner) an Ancillary Professional who agrees to cooperate fully with the *Professional of Record* and the process.
- d. The need for the *Professional of Record* to sign and obtain the signature of the Architect and/or Engineer of Record as applicable and "address" which includes contact facility: telephone/cellphone/email/fax. Signature shall include Membership Registration number of the relevant Professional or Technical Entity.
- e. Each *Professional of Record* and *Ancillary Professional* e.g. Electrician, Countersigning Architect, Engineer, Plumber or other needs to possess a current Trade License from the Belmopan City Council pursuant to the Trade Licensing Act, Chapter 6 of the Laws of Belize.
- f. A *"Statement of Property Fee Account"* showing a zero balance for the Parcel on which the project will be implemented.
- g. Agree to comply with the Belmopan regulations in regards to storage of building materials and construction debris and removal of construction debris.
