------Requirements for Submission-----

- 1. Completed Trade/Business License Application Form
- 2. Identification:
 - Valid Social Security Card or Passport
 For ALL non-Belizeans: Valid Permanent Residence
- 3. Proof of Business Registration:
 - o Businesses registered under the Companies Act, Chapter 247:
 - Business Registration Certificate
 - Businesses registered under the Companies Act, Chapter 250 (e.g.: INC., LTD., LLC., LLP.):
 - Certificate of Incorporation
 - Articles & Memorandum of Association
- 4. Proof of Ownership
 - o Property Owner:
 - Land certificate dated any time after 2016 or,
 - Land Certificate before 2016 must be accompanied by a Land Register Report dated within 3 months of issuance from the Ministry of Natural Resources.
 - Valid Social Security card or passport
 - o If renting:
 - Land Certificate or Land Register
 - Lease agreement that specifies duration and price of rent signed by a Justice of the Peace
 - Property owner's valid Social Security card or passport
 - o Rent Free:
 - Land Certificate or Land Register
 - Authorization Letter from Property Owner and signed by Justice of the Peace
 - Property owner's valid Social Security card or passport
- 5. Zero Balance on all fees owing to the Council.
- 6. Valid Food Handler's Permit for <u>ALL</u> establishments involved in <u>ANY</u> food preparation (i.e. Restaurants, Fast Food, Coffee Shop, etc.)
- 7. If application is submitted outside of the timeline of the quarterly schedule Businesses can pay \$150.00 for a Special Trade License Meeting.

➤ Incomplete applications Will Not be accepted by the Council.

Supporting documentation which can include: copy of licenses, accreditations, professional certificates etc., in relation to said business can be submitted for further consideration.

Trade License Quarterly meetings are held in
January, April, July and October.
